I am by direction to inform that the following are the guidelines for the function of Research Center which is approved by this University.

1. The prescribed fee for Establishment of Research Centre shall be Rs. 50,000/- (Rupees Fifty Thousand) and annual renewal fee shall be Rs. 5,000/- (Rupees Five Thousand). The said fee shall be paid in favour of "The Registrar, Tamil Nadu Physical Education and Sports University", payable at Chennai. The functions of Research Centre shall commence only after the payment of said amount for the University.
2. The application form for Ph.D programme shall be obtained from the university and the admission will be made only by the University through an entrance examination.

3. All the fees prescribed for Ph.D programme shall be paid to the university only.
4. The Scholars shall register for Ph.D in Research Centre under the guidance of approved Guides of concerned institution only.
5. The approved Guides of Research Centre can register the scholars in the concerned institution as per this norms of university /UGC.
6. The scholar should submit six month progress report for the University duly forwarded by the research supervisor and principal.
7. The scholar shall be permitted to conduct research and related course work in the Research center itself under the supervision of respective Guides approved by the Doctoral Committee.
8. Dissertation and synopsis must be submitted to the University in prescribed format.
9. Evaluation of Dissertation will be done by the duly formed examiners appointed by the University.
10. The Ph.D Pre-Viva- Voce and public Viva – Voce examination shall be conducted in the concerned Research Centre after receiving the direction from the University.

The Research Centre are directed to follow the above mentioned guidelines strictly.
